The overall quality of its analysis and writing

Your essay should be no more than five (5) pages, double-spaced, not including cover page, figures (graphs, tables, etc.), citations, etc. Please include a copy of all graphs or tables as an appendix.

The essay may follow any standard style format for a college paper. Include proper citations of all source material. The **Purdue Online Writing Lab (OWL)** is a good resource.

GRE SCORES

You may submit GRE Scores that are up to 5 years old from the date you plan to submit your application. For example, if you took the GRE on September 19, 2017, you may access and submit your scores from ETS until September 18, 2022.

If you have not yet taken the GRE, you will need to ensure that you take the test in time for your scores to be submitted to the Graduate Admissions office by the application deadline you are applying for.
