The clarity and coherence of its argument The overall quality of its analysis and writing

Your essay should be no more than five (5) pages , double-spaced, not including cover page, figures (graphs, tables, etc.), citations, etc. Please include a copy of all graphs or tables as an appendix.

The essay may follow any standard style format for a college paper. Include proper citations of all source material. The **Purdue Online Writing Lab (OWL)** is a good resource.

GRE SCORES
