This is your chance to demonstrate college level writing and critical thinking skills. The Admissions Committee will evaluate your essay based on:

The clarity and coherence of its argument

The overall quality of its analysis and writing

Your essay should be no more than five (5) pages, double-spaced, not including cover page, figures (graphs, tables, etc.), citations, etc. Please include a copy of all graphs or tables as an appendix.

The essay may follow any standard style format for a college paper. Include proper citations of all source material. The **Purdue Online Writing Lab (OWL)** is a good resource.

GRE SCORES

You may submit GRE Scores that are up to 5 years old from the date you plan to submit your application. For example, if you took the GRE on September 19, 2018, you may access and submit your scores from ETS until September 18, 2023.

If you have not yet taken the GRE, you will need to ensure that you take the test in time for your scores to be submitted to the Graduate Admissions office by the application deadline you are applying for. It takes ETS 10-15 working days from your test date to send your scores to your college(s) of interest. If for example, you would like to meet the First Round Application deadline of December 31, 2023, you will need to have taken the GRE by December 14, 2023, to ensure that your scores are received in time.
