The faculty discussed the two courses you describe below again. We were originally concerned (and remain somewhat concerned) that these two courses did not provide you with a sense of the methods used in social science or broader context of society-environment interactions that you might get in a course like "Social Science," "Political Economy," or "Society and Environment," or something similar.

However, we would be willing to accept the combination of these two courses to meet the pre-requisite for MES, with the recommendation (not requirement) that you gain some additional academic familiarity with the social sciences prior to fall of 2025. Taking a class in the social sciences prior to enrolling in MES would give you a stronger foundation to build on. However, I am willing to waive the Social Science pre-requisite based mainly on the recent Childhood Development course.
