Grading System Effective Summer 2004:

Each first year course, other than Legal Research and Writing, will have a mean grade point average between 2.600 and 2.900 (inclusive) for both December advisory and final grades. Each upper class course with an enrollment of 25 or more students, and/or which is required or highly recommended for graduation, other than Legal Research and Writing, will have a mean grade point average between 2.700 and 3.000 (inclusive). Legal Research and Writing I and II classes will have a mean grade point average between 2.600 and 3.100 (inclusive). Legal Research and Writing III and IV classes will have a mean grade point average between 2.800 and 3.300. For this purpose, multiple sections of the same course taught by the same professor in the same semester shall be treated as one course.
