ACCREDITATION:

Air University (AU) is a federal degree granting institution (10 U.S.C. §9417, §9415, and §9414) authorized by the U.S. Congress to award degrees appropriate to its mission under regulations prescribed by the Secretary of the Air Force.

Air University is institutionally accredited as a Level V degree-granting institution by the Southern Association of Colleges and Schools, Commission on Colleges (SACSCOC) to offer Associate's, Master's and Doctoral Degrees. Air University requested SACSCOC permission to separately accredit the Air Force Institute of Technology (AFIT) with Higher Learning Commission (HLC).

SPECIALIZED PROGRAMMATIC:

Air University maintains specialized programmatic certification under the Chairman of the Joint Chiefs for Joint Professional Military Education Level I and II.

AFIT maintains specialized programmatic accreditation under the Accreditation Board for Engineering and Technology (ABET) for selected programs within the AFIT Graduate School of Engineering and Management. Additionally, AFIT maintains specialized programmatic accreditation under the International Association for Continuing Education and Training (IACET) for programs in the AFIT Civil Engineer School.

Community College of the Air Force (CCAF) maintains American Bar Accreditation (ABA) programmatic accreditation for the paralegal program.

Normal inquiries about AU or AFIT, such as admission requirements, educational programs, transcript requests, and so forth, should be addressed directly to the institution and not to the SACSCOC or HLC offices. The commissions are to be contacted only if there is evidence that appears to support significant noncompliance with a requirement or standard of the accrediting body.

PRIVACY OF RECORDS:

PRIVACY ACT: As a federal education institution, AU must adhere to established federal and services policies and guidelines on records. Air University adheres to the guidelines of the Privacy Act of 1974 (5 U.S.C. ch. 5 § 552a:) to protect the confidentiality and integrity of student records.

FERPA: Air University is exempt from the Federal Family Educational Rights and Privacy Act or FERPA (20 U.S.C. § 1232g; 34 CFR Part 99). Air University is solely funded by the Department of Defense. AU voluntarily uses the basic tenets of FERPA in privacy of records.

ACADEMIC CALENDAR:

Air University has multiple term structures, including traditional semesters and accelerated formats.

CREDIT HOURS:

Air University degree programs are recorded in semester hours and non-degree programs are recorded in contact hours or continuous learning points. Curriculum Credit specifies the required courses for a degree program of AU/CCAF. Earned credit is accepted credit earned through instructors that are not affiliated with AU/CCAF.

SEMESTER HOURS:

Air University degree program courses are recorded in semester hours. Note: Course credit for the School of Advanced Airpower Studies (SAAS) and the School of Advanced Air and Space Studies (SAASS) for 1992-2005 is shown in quarter hours.

TRANSFER CREDIT:

Transfer credits accepted by AU are indicated on the transcript if the student was degree-seeking at AU. Transcripts are evaluated and credit equivalence is applied to the appropriate general education, elective, and major areas. The lowest acceptable transfer grade applied to degree requirements is a C; a maximum of 60 hours may be applied towards degree. Defer to catalog. Transfer credit is not calculated into the GPA.

CONTACT HOURS:

Air University non-degree program courses are recorded as contact hours or continuous learning points. Note: continuous learning points are recorded for courses associated with AFIT School of Logistics.

COURSE NUMBERING:

DEGREE PROGRAMS: Undergraduate degree courses are numbered in the series 1000, 2000, 3000, and 4000. Graduate degree courses are numbered in the series of 6000, 5000, 6000, 7000, 8000, and 9000.

NON-DEGREE PROGRAMS:

Non-degree courses are numbered in the series 0000 to 0999.
