- 4 quarter credits or 3 semester credits of statistics
- 4 quarter credits or 3 semester credits of natural science (e.g. biology, ecology, geology, chemistry, physical geography)

Completion of this coursework is required before you may begin the MES core sequence. Please be sure that official transcripts reflecting completion of this work is received by the MES office no later than October 12, 2018. Important notifications from the college and MES will be sent to your Evergreen email address periodically, so be sure to set it up immediately and check it regularly. Directions are enclosed. Starting now, we will send out paid internships, jobs, and other opportunities for MES students to this email. As a new MES student, you are required to enroll in the first MES core class: graduate Conceptualizing our Regional Environment, or gCORE. All core courses are on Tuesdays and Thursdays, 6pm-10pm. If you intend to finish in two years, you should also take an elective course along with gCORE. You may also take summer 2018 courses with MES as a special (non-matriculated) student – up to eight credits of these courses will count toward your degree. This year, the Fall quarter starts September 24, 2018. We will hold a mandatory orientation on Monday, September 17, 2018. All new students are required to participate. In mid-August, we will send more specific information by email and postal mail about orientation if you have accepted this offer of admission.

If you have not yet completed the FAFSA, you can do so at any time to be eligible for loans. Go to fafsa.ed.gov to apply.
