As a new MES student, you are required to enroll in the first MES core class: graduate Conceptualizing our Regional Environment, or gCORE. All core courses are on Tuesdays and Thursdays, 6-10pm. If you intend to finish in two years, you should also take an elective course along with gCORE. Fall registration instructions will come by email from the MES office. You may also take summer 2019 courses with MES as a special (non-matriculated) student – up to eight credits of these courses will count toward your degree. This year, the Fall quarter starts September 30, 2019. We will hold a mandatory orientation on Monday, September 23, 2019. All new students are required to participate.
