work in the Office of the Governor Christine O. Gregoire, incoming WGA Chair, for one year. The WGA will provide a \$40,000 stipend to the Fellow, concluding within 12 months of the starting date, and will reimburse travel expenses directly.

OVERVIEW

The Office of the Governor is accepting applications for the Western Governors' Association George S. Mickelson Memorial fellowship program. The one-year position is open to all Washington residents pursuing or completing an advanced degree who have a strong interest in public policy with emphasis on environmental, natural resource, land use, energy, and outdoor recreation issues.

The George S. Mickelson Memorial fellowship program was established in 1993 to honor former South Dakota Governor George Mickelson, who died in a plane crash that same year. Beginning in mid 2007, WGA enhanced the Mickelson Award, making it an even more prestigious, year-long internship for a graduate student in the field of public policy. The Western Governors' Association Fellow will be selected by the incoming WGA Chair through a competitive process to serve in the Governor's office during her year as Chair. WGA will provide a stipend to the individual and may assist the Governor in overseeing the

internship, including providing experiences on regional policy matters within the Western Governors' Association.

Fellowship Goals

- Foster and encourage young leaders in the fields of public policy and state government through a one-year, paid internship.
- Provide the WGA Chair with a highly qualified graduate to assist with the workload during his or her one-year term as Chair.
- Build a prestigious public policy internship program in the Western region that both draws on, and builds upon, the reputation of the WGA and that honors the memory of former Governor Mickelson.

DESIRABLE QUALIFICATIONS

- Fellowship applicants must be a graduate student (or recent graduate student) of any Washington State institution
 of higher learning, or a Washington resident who is a graduate student (or recent graduate student) at an out-ofstate institution of higher learning.
- Applicants should have a strong interest in public policy and an understanding of Western issues.
- Strong writing skills.
- Strong focus on issues related to the environment, natural resources, land use, energy, and outdoor recreation including the promotion of outdoor recreational tourism in the west and outdoor recreational opportunities for youth.

Interested applicants should submit the following:

- A letter of interest, describing specific qualifications for the position;
