## Earth and Spirit Conference by Bruce Baldwin

A conference on Earth and Spirit, "The Spirited Response to the Environmental Crisis," drew 110 people to Seattle in October. This was a full weekend of rituals and speeches, music and images, focus sessions and networking. Chinook Learning Center sponsored the gathering which drew leaders from Native American, Jewish, Christian, Buddhist, Goddess and other spiritual traditions.

Native American rituals opened and closed the conference, which was held at the University Christian Church and nearby locations. In the keynote address, Joanna Macy called us to, "practice the presence of the old growth forest...we have a multi-billion dollar industry to persuade us we are happy." She said it is very subversive to own our pain for the world. Our experience of profound interconnectedness with nature brings both deep grief and abundant grace. There were many inspirational speakers and workshop leaders, including Thomas Berry (*The Dream of the Earth*), Brian Swimme (*The Universe is a Green Dragon*), Christine Gregoire (Director, DOE), Billy Frank, Jr. (NW Indian Fisheries Commission) and Merlin Stone (*When God Was a Woman*).

Other highlights included a rich variety of music, poetry, projected images of Earth from space, dances of universal peace, and displays by various groups. Two members of the Penan Tribe of Borneo spoke about the threats to their rainforest homeland. A pre-conference institute was the first of four gatherings worldwide to prepare a spiritual statement for an international conference on the environment in 1992 sponsored by the United Nations Environmental Program.

This conference will not transform our civilization's relationship with the Earth or overturn predominant Judeo-Christian attitudes toward nature. It does, however, represent the growing strength of spiritual voices for humanity's unity with the natural world, and a unity among spiritual and ethnic traditions worldwide. My feeling is that strong spiritual forces are being released for planetary healing and that each of us can learn to work with them. # **Puget Sound Research Conference**

Over 3 million people live in the Puget Sound region today. In the next twenty years, another 1.5 million are expected to join us, drawn by the quality of life and the environment. Puget Sound faces a severe challenge in the changes that must accompany growth. Already it is showing signs of the strain, early symptoms of wear and poor management: toxic chemicals in urban bays, closed shellfish beds, destroyed and degraded wetlands.

As managers of our public and private resources struggle to stay ahead of the problems created by growth, they rely on our current understanding of the Puget Sound ecosystem, an understanding supplied and updated by research.

Continuing a tradition begun in 1988 with the first Meeting on Research in Puget Sound, Puget Sound Research '91 will present the latest in basic and applied research on the Sound and the problems it faces. This conference, presented by the Puget Sound Water Quality Authority, will be an opportunity for research sciences, resource managers, policy makers and the public to ask and try to answer some of the most important questions of our times.

Conference highlights include special sessions on public attitudes towards policy makers, technical and education issues, a curriculum exchange and much more. The conference takes place January 4 and 5 at the Washington State Convention and Trade Center in Seattle.

Student registration cost is only \$20 before December 15, and \$35 afterwards. For more information, call 284-2441 or 464-7597.
