Your admission to the MPA program requires that you **complete an MPA-approved 4 credit introductory statistics course** with a grade of "C" or better before you begin MPA coursework in Fall 2012. After course completion, please submit an official transcript by **September 15, 2012** to Jan Hays, MPA Office Assistant, at: MPA Program; Lab 1, Room 3019; Evergreen State College; 2700 Evergreen Parkway NW; Olympia, WA 98505. *Your admission to the program will be withdrawn if we do not receive an official transcript documenting completion of the statistics prerequisite by September 15, 2012.*

This offer of admission is dependent upon successful completion of any academic work currently in progress.

Re: **financial aid:** applications for federal student loan aid are still being accepted. To apply for federal student loans, your first step is to complete the federal student aid form, the "FAFSA". After we receive your tuition deposit, **Fall 2012 course registration** instructions and information about Fall courses will be emailed to your **Evergreen email address**.

Please note that while Fall quarter classes begin on Monday, September 24, 2012, we will be starting your first year Core course a bit earlier, with an intensive weekend class meeting and orientation to the MPA program **on Friday, September 21 from 6-9pm and Saturday, September 22 from 9am-5pm.** During the summer we will send more detailed information about Orientation to you. *Please note that all students in first year Core are **required to participate** in this weekend meeting.*
