	Leslie Dierauf, the U.S. Geological Survey's Regional Executive for the Northwest (WA, OR, ID), will offer a presentation describing U.S. Department of the Interior efforts related to the Northwest Climate Science Center, and a draft Northwest Climate Science Agenda (attached). The purpose of this session will be to offer individual Tribal Nations within the Affiliated Tribes of Northwest Indians the opportunity to comment on, add to, or otherwise modify key science needs the Tribes believe they will have in order to manage and sustain their lands, waters, and first foods in the face of a changing climate. Planning an ATNI Congressional-Tribal Leaders Forum

Presenters: Kara Briggs, Senior Strategist & John Hoyt, Pyramid Communications

The leadership of the Affiliated Tribes of Northwest Indians is working with Pyramid Communications to develop a one of a kind Leadership Forum that would bring together members of Congress from ATNI's five states and tribal leaders of ATNI for a round table discussion. In preliminary research, staff from the Congressional offices expressed an interest in this potential event to be hosted next spring, likely by the University of Washington, and to be broadcast live on television in all five states. Coming in the middle of the campaign season, this forum would position Northwest tribes as national leaders in natural resource and other issues. During the breakout session Pyramid Communications will report on findings of initial research and facilitate a group discussion about potential outcomes and features of the forum.

- Members of Congress will likely attend because of their constituents and donors, and if tribal nations within their states ask them to
- Leading up to an election year, tribes play an important role in turning out citizens to participate in the election process and helping to financially support candidates
- The gathering will take place on Northwest tribes' home turf, resulting in greater media coverage than if the event was held in D.C.
- There could be an opportunity for elected leaders to host fundraising events around the leadership gathering
- There will have just been a great deal of national attention on the removal of the Elwha and Condit dams, which will have focused attention on the Northwest and its abundant natural resources
