Introduction

The UALR Institute of Government Survey Research Center (SRC) conducted a survey at the request of the UALR/IOG Master in Public Administration (MPA) department. The purpose of the study was to assess the opinions and perspectives of currently enrolled MPA students regarding the program, classes, teaching format and other issues. The results from this survey will be used to make better decisions concerning the MPA program and to better serve the needs of its student body.

Methodology

The target population was students enrolled in any MPA class during the fall 2012 semester. The MPA coordinator's office provided a database to the SRC of emails for the students. The population database used for the study consisted of 56 eligible students.

The survey was conducted between November 27, 2012 and December 11, 2012. A total of 40 individual interviews were completed for an overall response rate of 71 percent.

Data Analysis

Descriptive data analysis is presented which includes frequency distributions. Counts and percentage frequencies are presented for the sample as a whole. Also included are the comments from the open-response questions.

Can get same degree quicker and cheaper from ASU with many online options and credit for government employment.

Limited selection of electives reducing ability to specialize in a particular subject matter. High acceptance rate, early courses not entirely that challenging. Lack of communication for other potential course or internship opportunities and how they might fit within the MPA program. Older facilities that lack basic functioning technology, such as projectors.

I don't believe this program is going to pay off in the long run.

Q26 In what ways has your experience in the MPA program helped you to move towards your professional or career goals?

(Multiple Responses)

Many research topics what I did is helpful for me to know which direction of public administration is suitable for me. When furthering the research, there are more thinking about it. I feel it is really great let me to focus more on my career goals at some point.

The program has provided me knowledge of public and nonprofit organizations that I could not find in other management or administration programs. In addition, each provides an element of service and ethics that is vital to public administration. Overall, the program is providing me tools to begin a career in the public or nonprofit sector.

I will be able to apply for better jobs.

It has helped me professional look at my current field and evaluate whether or not I see myself here long term.

It helped to secure a leadership position/career change with a state entity.

I have developed a more well-rounded knowledge of all aspects of nonprofit management. Coupled with my CPA certification, the MPA will allow me to continue to grow into areas of management outside of finance alone. Within finance, it has given me more insight into what managers in other areas deal with, which allows me to be more prepared for interactions with them.

Credentials are necessary to advance.

Has helped me realize what direction I want to go in my career and has inspired me to pursue further education.

Provided me with a qualified Master's degree that will aid me in the future and met my own personal educational goal.

The program has exposed me to much needed experience in public finance, grant writing, and HR skills that I have otherwise missed in the course of my career. Additionally, it has improved my analytic and communications skills.

My MPA degree will give the knowledge and the qualification I will need to move to higher GS levels.

It has helped me to better understand the details of how public organizations work.

I feel like I have learned a great deal, and I am confident that I will be able to find employment after graduation. I have also formed a great network of fellow classmates and teachers that I know will benefit me in finding a job.

The program,Äôs subject material is specific to my work in the public sector. It has provided greater understanding of why things work the way they do and how I (in my role) can further impact the organization.

I work in federal law enforcement and am also a lieutenant colonel in the Army Reserve specializing in civil affairs and psychological operations. A degree from this program greatly benefits me in each profession. In law enforcement, the degree prepares me for supervisory positions within my agency as well as my "post retirement" job with a state or local law enfocement agency. My goal is to retire from my federal position and obtain a position as chief of police, administrator of a drug task force, or director of emergency management. A degree is necessary in the military for promotion to colonel. Additionally, I utilized my experiences from this program during my two deployment to Afghanistan working with Afghan government officials at all levels of government (district, provincial, and national).

I have been able to apply leadership skills, etc. to the current job I have. Understanding public administration is very important for decision makes such as legislators. Learning how organizations operate help to make wise decisions for the organizations and others that depend on the organization. Given the current political and economic climate, public administration has to be "re-thought" and I believe this program is key in helping to change and begin that conversation.

Instructors and course content

The reputation of the UofA system was very important when I decided on a program (online vs local). The convenience of attending classes locally was equally important. I enjoy a class format more than online although I do see the benefits of online programs. Every instructor was friendly, knowledgeable, and willing to work with me when either my duties with my job or military interfered with class. The availability to attend evening classes. The change to the final capstone class. A "real world" group project is much more interesting and beneficial than writing a paper.

Faculty

If one is willing to seek out advise and help from a faculty member regarding a personal endeavor they are willing to assist in what ever way they are capable of. This includes letters of recommendation, fellowships, networking with potential employers, and furthering research opportunities.

The strengths of the MPA program is the analytical skill training and writing that we have to do. It forces students to think outside the box and break down policies that are not easy to comprehend and thus causes our mental capacity to expand.

Q28 What would you change about UALR's MPA program and why? (Multiple Responses)

Extend more cooperative programs or more extensive courses available.

I would like to see more specialty emphasis fields, such as health care, because that would provide students the opportunity to mold their field and the program to collaborate with other educational entities.

I would offer more electives. The sheet students use to track their progress lists many electives but most of them have not been offered in years. It is the same set of electives each semester. This makes it hard to develop interests and abilities in areas of Public Administration that are not addressed by the standard set of electives.

Group work - at least the way much of it currently is done. There should be a better way to grade the students that do not contribute to the group in a meaningful way. As of now, they coast on the work/grades of the more prepared students.

Tighten admissions standards. Conditional admits should be the exception versus the rule. I have come across many fellow students with one or both of the following: fairly low undergrad GPAs and/or poor writing skills.

Streamline the communication preferences of the professors in the department, some prefer blackboard, other do not utilize it at all. Some require printed copies of assignment while others prefer them to be turned in electronically. And the advising and course registration process is poorly managed.

Until this semester I haven't received as much feedback as I would like on my research papers. As each class builds to the next I find feedback to be valuable. Other changes would be the location of the classes. Ross Hall is not in the best shape. I often worry about security walking back to the parking lot at night. It is not the best lit part of campus.

I would like to see electives offered more often. I listed the variety of electives as a strength, but the frequency at which they are offered sometimes leaves students with no choice as to which elective they "elect".

Consider offering more classes in a weekend format...both electives and possibly core classes. These classes seem to be well attended and would allow working students additional flexibility in scheduling classes. Sometimes adding another night through the week it too much, but giving up a few weekends is doable.

I would make the admissions process more selective

The facilities are horrendous.

More class options so that you are not forced to take certain classes because others are not offered that semester.

I believe most of the concepts presented throughout the program are largely theoretical and not practical. I felt some of the most helpful, and quite frankly, most interesting discussion and learning took place during courses where knowledge can be practically applied.

The team-based capstone design should, if implemented, only be required of students accepted to the program after the design was put in place. It is unfair to change the requirements for those who began the program with the expectation that the capstone would be a personal effort. Students should also have the option of writing a thesis in place of a capstone.

The facilities must be improved. Ross Hall is poorly lit, unsanitary, and contains outdated technology. The classrooms are uncomfortable. Additionally, the program staff and the School of Government in general must demand that UALR do more to reduce crime on campus.

I would like to see a wider selection of classes.

The classrooms are a mess, and it becomes very uncomfortable and distracting when you have to sit there for long periods of time. Find a better set of classrooms or remodel the ones you have. Also, instructors that adhere to a strict attendance policy need to realize that some of us are parents and we have jobs and responsibilities that reqire us to miss classes sometimes. Our work and various positions require late nights at the office or travel. We should be allowed to miss without being penalized as long as we let the instructor know ahead of time.

First I would change the venue where the classes are taught. To put it bluntly Ross hall is horrible it is falling apart! The next thing that I would like to see changed is most of the professor's reliance on Blackboard. I hate Blackboard and it has historically given me problems when attempting to turn in assignments. Why cant the MPA program offer any daytime courses? Finally, and this is going to sound like a minor issue, but I am sick of putting a \$1.25 into the vending machines on the third floor of Ross Hall in an attempt to get a pepsi and all the machine will spit out is a orange Crush. I don't drink that, it doesn't even have caffeine in it.

Classrooms are drab (and COLD)...the temperature can make for some very uncomfortable lectures.

THE CLASSROOMS! I understand this is not necessarily a problem with the MPA program and more a budget issue with the UofA system. However, between all of my training and education over the years the classrooms used by the MPA program at UALR compete for the worst. In my current class there is insufficent space to sit at a desk. The entire course I had to pull a chair up and sit by the door.

Classrooms. very uncomfortable and old.

Multiple options for capstone wouldbe welcomed. I am a fan of the new group consulting model i feel that it will provided real experience utilizing what we have been taught in the program in addition to a welcome resume boost. I would like to see other options retained such as the thesis or mini thesis options that the program had previously. I would also like to make the suggestion of and individual capstone project similar to what the Clinton School of public service offers. This program allows for students to partner with an organization to accomplish a meaningful task. This is some what like a fellowship. This options allows for the experience to be more tailored to the students personal career interests. This would most likely require a dedicated staff member to help maintain the connections formed by the students.

Academic rigor. Some of my earlier courses are entirely too easy and did not reinforce the materual that was taught. I would also like to have required basic statistics course followed by a reasearch methods specific to PA (similar to the current methods class). Other elective research courses would be helpful for building usable hard skill's. these would included GIS training, SPSS, and Excel. Theses could be offered in a work shop format perhaps or one credit hour courses. I would also like to see a budget tools course as well to address more technical aspects.

The MPA program itself is pretty good in my opinion. Probably one thing that would be of assistance to students for future writing assignments is to allow them to interject their voice more into assignments to show that students have a better comprehension of what is being asked of them. This helps to develop flexibility in writing so students are able to determine which writing style is needed at a particular moment versus only relying on one style of writing.

Maybe the work load. Some professors give you 30hrs per week of homework, that is not necessary. Perhaps projects that allow us to apply the reading is more helpful in some cases.

Don't know enough to be critical of anything.

I would change how social issues are discussed in the classroom setting. Some students feel very uncomfortable with dealing with some if not most social issues, such as race, gender, and class. These social issues affect Americans daily, I would change how it is discussed because students not only need to be introduced to some if not most of the social concerns especially in their historical context as well as in its current application because how can we as public servants truly serve the people if we don't know or are not willing to address social issues.

I would also change the range of courses to be added to the curriculum such as courses that include more federal government career paths and not just state and local career paths. I think that changing or increasing the range of courses offered that deals with foreign policy as well as domestic policy would make the program more fulfilling.

I would increase the electives offered. I was excited to take Admistrative Law when I began the program. However it was never offered.

The admission standards to the program should be changed. It seems that the program accepts anyone and everyone of applies. I'm alarmed by the lack of intelligence of some of the people who gained admission into the program. Seeing this doesn't make me confident I entered into a high quality MPA program.

Also, I feel that program is too heavily geared toward non-working students in terms of course content. I understand this in a way because many (in my opinion too many) students do not have full time jobs. However, it seems that much class time is spent trying to explain things in a way that non-working students understand happens in the "real world".

online classes - at least for the electives... hard to devote one night a week with job and young children

There needs to be more flexibility in class time schedules. It would also be nice to have more elective choices.

The advising process and to add some classes to be on-line.

Make electives more available; It put me back a semester

Create more of a diversity of courses.
